As of December X, 2025, Bumble does not market or sell voluntary carbon offsets within the meaning of AB 1305.

§ 44475.1: Disclosure Information Related to Purchased Carbon Offsets

Bumble purchases third-party-verified carbon offsets as part of its efforts to achieve net zero emissions in its company operations.

While Bumble purchases offsets to neutralize certain aspects of the emissions associated with our operations, our primary aim is to reduce our overall footprint through operational efficiencies, supplier engagement, and other initiatives.
