

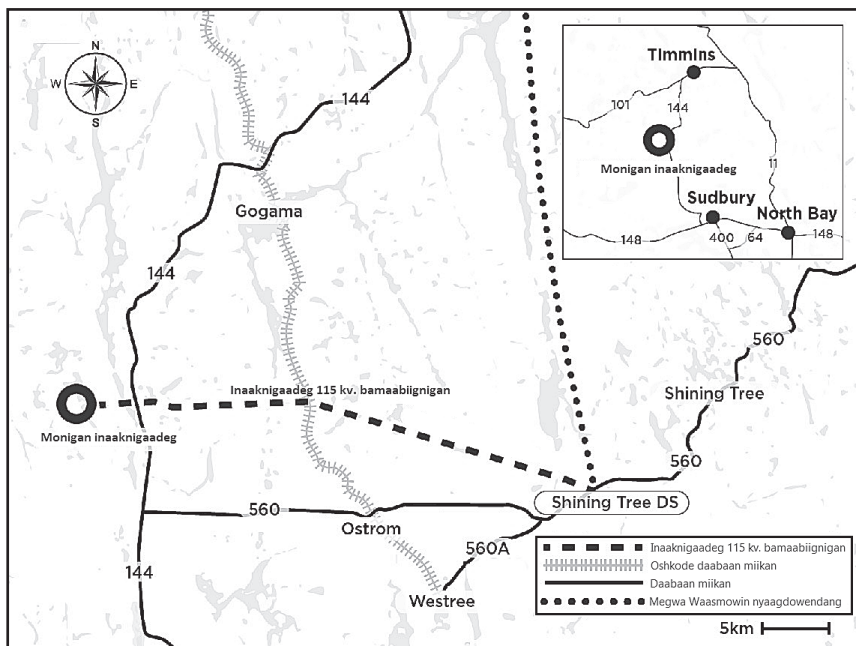

Woshme awii Gikendaman

IAMGOLD Maamawichigewin gagwejmamaan Ontario Waasmowin Nyaagdowendamajig (OEB) awii baginigaazwaad awii zhitowaad megwaach agwa 44 bimisewin owi 115 gichi waasmowin awii bamibdeg biiwaabig. Owi waasmowin biiwaabig bimaabiising awii zagibijigaadeg odi Cote Gold Mine odi etemgak megwaach agwa 20 km Zhawina-epigishmag zhiwe Gogama, Ontario owi Ontario Waasmowin Inc.s bemaabiig izhichigewin odi Shining Tree dagoobdeg.

IAMGOLD Maamawichigewin age adoo gagwejmamaan OEB awii minwamdawad awi mazinigan naasaabndamowin gewe aki debendamajig awii nikaazang ado kiimwaa awii bimaabiising maage awii zhichigaadeg owi biiwaabig.

Aki mazinigan owi enaakinigen awii bemaabiisin owi biiwaabig maampii ezhibiigaadeg niisa-iing.



Owi OEB n'jike gaabwiimgad miinwaa gaawii aasgaabwitwaasin gwaya bemaadzijig debendamowaad. Ada bamibdetoonaa-aa bemaadzijig bizindaajigewin awii dibendamowaad IAMGOLD maamawichigewin gagwedwewinwaa. Epiichi bazindaajigeng, owi OEB ada dibendanga gikenjigewin miinwaa aazhidendwinan owi **IAMGOLD maamawichigewin** gewe bemaadzijig, odenwinan miinwaa aanin ado masenjigewinan age madookdaagemgag.

Owi OEB bazindaajigewin ada dabegendaan memdage zngendamowin agaa wenaamjigaadeg owi onashowewin. Owa Ontario Waasmowin Nyaagdowendamajig (OEB) 1998 zhibii-aanaa-aan zngendamowinan owi OEB awaa dabengandag apii zhitood giizhendawin. Giishpin dowendaman awii dagokaazyin zhiwe OEB bazindaajigewin, kitchi piitendaagwad awii nsastaman newen zngendamowin yaawang.

Ezhi dowendaagwog owi **Ontario Waasmowin Nyaagdowendamajig Naaknigewin** owi OEB ada dabegendaan ninda zngendamowinan:

- Ado msendamowinan gewe e'yaa'jigejig owi engindeg miinwaa ezhi penmandaagwog miinwaa epiich nishing waasmowin izhichigewin;
- Owi gagaandnigaadeg owi aanke nikaazan waasmowin endanigaadeg e'wijiijemgag newen naaknigewinan owi Ontario Gimaa Gamig; miinwaa
- Owi dnowaa bezhigwendmowin mazinigan owi **IAMGOLD Maamawichigewin** e'bagidnigewaad gewe aki debendamajig e'madookdaagwaad owi waasmowin bamibdeg biiwaabig.

Owi OEB bazindaagewin gaawii agwa n'jike aawizino bagidinigewin enakiin jibwaa zhichigaadeg owi biiwaakoons. Dabishko gonaa, Ministry of the Environment, Conservation and Parks' aki mdookdaagewin dabizhigan. Owi OEB ndakenjigewin ada gnowaamdaanaa-aan newen nisiwi zngendamowinan ezhibiigaadegin maampii shpiming miinwaa gaawii ada gnowaamdaziinaa-aan bkaan dnowaa bebaamendaagwog, dibishko gonaa, aki mdookdaagewin, mina yaawin, enaabminaagwog maage epiitendaagwog dibinoweziwin ezhi mdookdaagaadeg.

GIKENDAN EZHIWEBAK
