Nucor Announces Guidance for the Third Quarter of 2023 Earnings

CHARLOTTE, N.C., Sept. 14, 2023 /PRNewswire/ -- Nucor Corporation (NYSE: NUE) today announced guidance for its third quarter ending September 30, 2023. Nucor expects third quarter earnings to be in the range of \$4.10 to \$4.20 per diluted share. Nucor reported net earnings of \$5.81 per diluted share in the second quarter of 2023 and \$6.50 per diluted share in the third quarter of 2022.

We expect earnings for the steel mills segment to decline in the third quarter of 2023 as compared to the second quarter of 2023 primarily due to lower pricing, and to a lesser extent, volumes. The largest impact on earnings is expected to occur at our sheet mills. The earnings of the steel products segment are expected to decrease in the third quarter of 2023 as compared to the second quarter of 2023 also due to lower realized prices and volumes. Earnings for the raw materials segment are expected to decrease in the third quarter of 2023 as compared to the second quarter of 2023 due to margin compression at our DRI facilities and scrap processing operations.

During the third quarter, Nucor has repurchased approximately 3.0 million shares at an average price of \$168.99 per share (approximately 8.8 million shares year-to-date at an average price of \$157.36 per share). Nucor has returned more than \$1.76 billion to stockholders in the form of share repurchases and dividend payments year-to-date.

Third Quarter of 2023 Earnings Release and Conference Call

Nucor will release its earnings before the markets open on Tuesday, October 24, 2023, and will hold a conference call that morning at 10:00 a.m. Eastern Time to review the Company's third quarter results followed by a question-and-answer session. The event will be broadcast on the internet, and instructions on how to access will be sent closer to the call.

Nucor and its affiliates are manufacturers of steel and steel products, with operating facilities in the United States, Canada and Mexico. Products produced include: carbon and alloy steel -- in bars, beams, sheet and plate; hollow structural section tubing; electrical conduit; steel racking; steel piling; steel joists and joist girders; steel deck; fabricated concrete reinforcing steel; cold finished steel; precision castings; steel fasteners; metal building systems; insulated metal panels; overhead doors; steel grating; wire and wire mesh; and utility structures. Nucor, through The David J. Joseph Company and its affiliates, also brokers ferrous and nonferrous metals, pig iron and hot briquetted iron / direct reduced iron; supplies ferro-alloys; and processes ferrous and nonferrous scrap. Nucor is North America's largest recycler.
